- Counselor/Advocate will provide free, confidential, specialized direct services to primary and secondary victims of sexual violence after office hours, on weekends and holidays, as scheduled, via confidential, non-directive counseling, advocacy, and related services.
- Provide accompaniment services at any hospital and law enforcement agency within Chemung, Schuyler and Steuben counties.
- Attend monthly meetings for case review and training. Assure quality care at all times.
- Maintain DOH Rape Crisis Counselor/Advocate certification via successful completion of mandatory continuing education hours.

Qualifications:

- Bachelor's degree plus 0-2 years relevant experience; or Associate's Degree plus 2-4 years relevant experience; or High School Diploma plus 4-7 years relevant experience include Women's Studies, Psychology, Sociology, Counseling/Advocacy, or Rape Crisis/Victim Services.
- Commitment to the mission, goals and values of the Sexual Assault Resource Center and Planned Parenthood.

- Excellent organization, communication, and teamwork skills.
- Ability to reliably and promptly travel throughout Chemung, Schuyler or Steuben County.
- Must be able to work evenings, overnight, weekends, and holidays as scheduled
- Ability to complete the NYS DOH Rape Crisis Counselor/Advocate certification.
- Ability to work independently.
- Ability to establish and maintain effective working relationship with clients, other staff, volunteers, and community service providers. values teamwork.
